# **Departmental Voting Procedures Review**

Who may vote

All tenure track and teaching track faculty at 50% time or greater

Research professors of all rank at 50% or greater

Fulltime Instructors, lecturers, or artist in residents of all rank

Retired Tenure Track, Teaching Track, research professors of all rank during the quarter they are employed

# **Proxy Vote**

In the department, we have allowed in certain situations for people who know they will not be able to be present for a vote, to give their vote to another voting faculty member to vote on their behalf or a Proxy Vote.

The faculty code does not make it clear whether it is allowed of not.

Different departments on campus have different policies

For example in CBE

Landscape, Arch and Construction do not allow proxy but they allow absentee voting

UDP's current policy on proxy voting seems to be out of step with the other departments in the college.

It is Christophers suggestion to eliminate proxy voting but allow absentee voting

### Discussion:

It would be nice if we had a way to organize votes in a way that's available to those who are absent. Could we look at votes prior to the meeting OR after??

If anyone suggests a secret ballot at any time..this should be allowed

Personnel issues are to be decided by secret ballot but per above, can be requested at any time

If someone is absent..there's some concern that they are missing the exercise of discussion

Also concern of voting after the meeting

For personnel, we really need to have people that are present and at the meeting voting

One argument in favor of proxy..if you can't make the meeting...you can give your vote to someone who you know would vote in a similar way that you would..

Christopher will work on a policy to bring back for a vote. Jan W has volunteer to review and comment Can we also have policy review/revision of FAR's?? Yes, we will be looking at this as well
